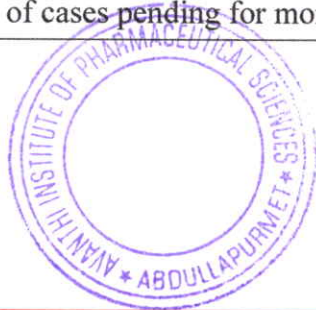

## Anti-Ragging Awareness Programme Report

The program commenced with the prayer song by 2<sup>nd</sup> year students and the guests were welcomed. The Chief Guest was formally greeted and welcomed by the Dr. K. Balaji, Principal and Dr. Y. Jayapradha, anti-ragging committee co-coordinator of Avanthi Institute of pharmaceutical sciences.

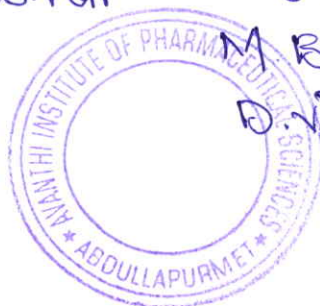

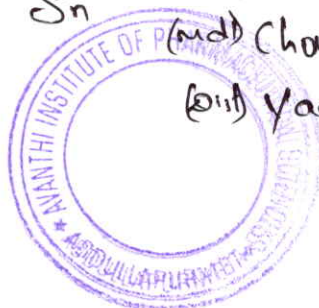
